Meeting was called to Order by Attorney Moses. Attorney Moses called roll for the Council, Mayor and Borough Officials. The Pledge of Allegiance was recited by all.

COUNCIL AND BOROUGH OFFICIAL PRESENTATIONS

Lisa Wildes – Ms. Wildes began by indicating she spoke with Dave Watkins regarding the property at 6260 S. Main St. The fire and police departments have executed the required paperwork, and now Council needs to reach out to Reilly Engineering to obtain a determination regarding the state of the property.

Additionally, Ms. Wildes indicated the Family Dollar Parking Lot is in poor condition with tires and refuse throughout. Dave Watkins responded that it is likely due to the methadone clinic in that area and that he would send them a letter.

Frank Sorokach – Nothing for this meeting.

Gerald Maldonado – Mr. Maldonado began by returning to the issue of the fence at the Main St. Park. The fence is still not repaired. Mr. Byra indicated he will get it repaired this week.

Additionally, Mr. Maldonado stated that the swings at the park have significant ponding in and around them. Mr. Byra stated that will be rectified once mulch has been laid down.

Mr. Maldonado also provided an update on the street section between Fall St. and Cook St., informing Council that residents cleaned one side but the other side is still in poor condition. Ms. Wildes responded that the Street Department was responsible for cleaning one side, not the residents.

Further, Mr. Maldonado indicated the Borough requires no dumping signs and posts from the Street Department to stop people from throwing garbage in that area. Mr. Sorokach replied the dumping may be due to people throwing garbage from Interstate 81. Mr. Maldonado responded that it is unlikely due to the speed cars are traveling.

Lastly, Mr. Maldonado asked about the expenses incurred by the Ashley Economic Development Authority that amounted to approximately \$20,000.00. Attorney Moses addressed this issue by stating that the Authority did not conduct audits so there is no record of expenditures, but it is his belief that the majority of expenses were likely Solicitor Fees. Mr. Maldonado asked Attorney Moses to follow-up to determine the nature of the expenses.

Brian Casey - Not Present.

Carl Byra – Mr. Byra requested the Finance Committee schedule a meeting in the near future to discuss financing related to a fire truck which will result in savings to the Borough,

Mayor Donald Sipple, Sr. – Nothing for this Meeting.

Chief Fedorczyk – Chief Fedorczyk read the Police Chief's Report (a copy of which is attached hereto and made a part hereof).

Additionally, Chief Fedorczyk requested Council act on a request for a handicapped parking space at 87 Carey St.

Dave Watkins – Mr. Watkins reported that in March 2021 he performed 10 occupancy inspections, posted 3 units – 6260 S. Main, 83 N. Main and an apartment near S&J. He issued 5 citations and shut down 2 jobs for lack of a permit.

Mr. Watkins also indicated that the sidewalk cuts discussed at the last work session will be repaired soon. Mr. Sorokach also thanked Mr. Watkins for his quick response to a yard waste issue.

Attorney Moses informed the public that Council met briefly in executive session tonight to discuss a potential litigation issue.
