

#### **PUBLIC COMMENT**

Thomas Hart complained about the new owner of 23 Vine St parking in the middle of the road not leaving enough room for emergency vehicles to get through. Sgt. McGlynn agreed that no parking signs may be necessary.

Tom Lawson had a complaint on the same address but added that they are blocking his vehicle and parking space.

Jim Loftus again complained about 23 Vine St and added that he drives a large utility truck and is on call 24/7. He cannot get around the vehicles. He added that this person is parking on other people's property, speeding in the alley and there is concern about children playing in the alley. He asked for no parking signs and children at play signs.

Lorraine Bilski complained about 14 Rutz St. She stated that they are working on vehicles on the street. There is a strong smell of gasoline, they are blocking the road and their children are laying in the middle of the road. Mr. Watkins said he will check on the property and also check with the Zoning Officer. As for the children he suggested calling Children's Services.

Stacy Loftus revisited the subject of 23 Vine St. and the parking situation. She suggested speed limit and children at play signs. It was also suggested that they

were doing renovations without a permit. Mr Watkins asked that he be informed if the residents noticed any building materials going into the property.

One resident noted that the Police are doing an excellent job but that the owners of 23 Vine St comply only when the officers are present.
