Meeting was called to Order by President of Council, **John Gibbons**. **Attorney Vinsko** called roll call for the Council, Mayor and Borough Officials. The Pledge of Allegiance was recited by all.

Mr. Gulick opened the meeting stating that Matthew Williams is going for his Eagle Scout Project and he will be doing work in the Chester Trout Stocking Area. He will be constructing an informational sign and placing garbage cans. He asked for Council approval to do work in that area. Mr. Gulick also announced that the 2019 Minimum Monthly Obligation (MMO) is zero (0) for the pensions. The Borough will need a resolution to accept the MMO. Next, Mr. Gulick has the contracts for health insurance that would have to be reviewed in executive session.

Mr. Casey stated that a member of the road crew (Mike) hurt his back pulling the mower off the back of the dump truck. He asked that we get a trailer so that the crew can move the mower and the roller. The trucks already have a hitch so we do not need that. **Mr.** Casey also suggested that the Borough make Mr. Capasso a sergeant from a patrolman with no rate increase. That would be considered as a resolution.

Ms. Schappert and **Mr. Sipple** discussed the K9 shirt sale, confirming that they would be sold for \$15.00, but the Borough would get a price break to buy in bulk now. The purchase price authorization would be approximately \$2,500.00.

Mr. Gibbons announced that he had prices on sliding boards. They ranged from \$4,400 to \$4,800.00. Mr. Gulick stated that we cannot get eight foot (8') stand alone slides any longer. The prices were \$4,400 for a six-foot (6') wave slide, \$4,440 for a straight slide and then the prices increased from there. Mr. Sipple asked if the Borough purchased now, can it be moved to the other park? Mr. Gibbons said no because it will be cemented in. Ms. Schappert asked if the other park would be ready soon. Mr. Gibbons said that he is down to the last pieces, which would be the removal of the railroad ties and the testing of 2 piles for environmental issues. Mr. Maldonado raised a concern that there would be three to four more months where the children would be going to play while waiting for parents. Mr. Casey suggested that it be ripped down now. Mr. Gulick said the current set up is too old and the Borough cannot use the other setups. Mrs. Coleman stated that the picnic tables are gone. Mr. Gibbons agreed and said that there are 23 picnic tables missing from the little league. Mr. Casey asked if the Borough could move the fence and put in a chain link. Mr. Maldonado said that the children would still climb a chain link fence, but that he would like to take a look at it. Mr. Gibbons stated that the Borough could address at the next meeting. Mr. Maldonado asked that the Recreation Committee meet and address it. Mrs. Coleman, from the audience, asked that the Borough be good stewards of the money and do not spend \$4,000 on the old park when the Borough could put it into the new park. Mr. Maldonado responded that one child got hurt on concrete after the slide was removed. Mr. **Sorokach** stated that the Recreation Committee will take a look.

Executive Session Held

The Borough Council then took an executive session to address the health insurance contracts for discussion and ultimate resolution in public.
